

MEASURES IN EFFECT FROM 8 MARCH TO 3 April

Avoid traveling

Both incoming and outgoing from the territories, as well as within the same territory, people are merely required to move for:

- working needs;
- situations of necessity;
- health reasons.

It is permitted to return to your home, residence or place of residence.

Health and respect for quarantine

People with symptoms of respiratory infection and fever greater than 37.5 °C are strongly recommended to stay at home and to limit social contacts as much as possible, contacting your General Practitioner.

For persons subject to quarantine measures or positive for the virus, it is absolutely forbidden to leave their own house or domicile.

Nursery, schools and universities suspended

Educational services are suspended for children, educational activities in schools of all levels as well as the attendance of school and higher education activities, including the Universities and Institutions for Higher Education in Arts, Music and Performing Arts, professional courses, masters, courses for the health professions and Universities for the elderly, as well as professional courses and training activities carried out by other public entities, including territorial and local and private entities.

There is still the possibility to carrying out distance learning activities, with the exception of courses for doctors in specialized training and specific training courses in general medicine, as well as the activities of interns in the health professions.

Organized events, cinemas, theaters, bingo halls, discos are suspended

All activities are suspended in the following places: cinemas, theaters, pubs, dance schools, game rooms, betting rooms and bingo halls, discos and similar places. All organized events are suspended, as well as events in a public or private place, including those of a cultural, recreational, sporting, religious and exhibition nature, even if held in closed places but open to the public, such as, for example, major events.

Museums and libraries closed

Museums, libraries and archives, archaeological areas and parks and monumental complexes are closed.

Restaurants and bars open from 6 to 18, one meter apart

Restaurant and bar activities are allowed from 6.00 to 18.00, with obligation, at the expense of the manager, to put in place conditions to guarantee the possibility of respecting the interpersonal safety distance of at least one meter. In case of violation, the penalty foreseen is the suspension of the activity.

Commercial activities other than restaurants and bars are permitted on condition that the manager guarantees access in a quota-based manner or in any case suitable to avoid gatherings of people, taking into account the size and characteristics of the premises open to the public, and such as to guarantee the goes the possibility of respecting the distance of at least one meter. In case of violation, the penalty foreseen is the suspension of the activity. In the presence of structural or organizational conditions that do not allow compliance with the interpersonal safety distance of one meter, these activities must be closed.

Closure of medium and high sales structures on holidays and on holidays (except pharmacies, parapharmacies and food outlets)

On festive and pre-holiday days, medium and large sales structures are closed, as well as the shops inside the shopping centers and markets. On weekdays, the manager must, in any case put in place conditions to guarantee the possibility of respecting the interpersonal safety distance of one meter. The penalty for failure to comply is the suspension of the activity.

In the presence of structural or organizational conditions that do not allow compliance with the interpersonal safety distance of one meter, these structures must be closed.

The closure is not amenable for pharmacies, parapharmacies and food outlets, whose manager nevertheless holds liable to ensure compliance with the interpersonal safety distance of one meter, under penalty of suspension of the activity in case of violation.

Suspended gyms, swimming pools, sports centers

The activities of gyms, sports centers, swimming pools, swimming centers, wellness centers, spas (except for the provision of the services covered in the Essential Levels of Care), cultural centers, social centers, and recreational centers are suspended. In addition to these activities, day-care centers are also suspended in the other provinces, based on the order of President Bonaccini.

Places of worship. Suspended funeral ceremonies

The opening is conditioned to the adoption of organizational measures, such as, to avoid gatherings of people, taking into account the size and characteristics of places, and such as to guarantee the goes the possibility of respecting the distance of at least one meter.

The civil and religious ceremonies, including funeral are suspended.

Competitions and sporting events

Sports events and competitions of all kinds and disciplines in public or private places are suspended. Their working out remained permitted, as well as training sessions for professional athletes and top class athletes participating in the Olympic Games or to national or international events, in sports facilities used behind closed doors, or outdoors without the presence of the public.

In any case, the associations and sports clubs, through their medical staff, are required to carry out the appropriate checks to contain the risk of spreading the COVID-19 virus among athletes, technicians, managers and all accompanying persons who participate.

Skiing facilities in the ski areas are closed

Use of holidays and leave

Public and private employers are recommended to promote the usage of their employees' ordinary leave and holidays, provided that, the provisions of the rules for work structure implementation.

Suspended competitions

Public and private competitive award procedures are suspended with the exception of cases in which the assessment of the candidates is carried out exclusively on curricular basic or electronically.

Excluded from the suspension, are the competitions for health personnel, state exams and qualification examinations for the practice of surgeon and civil protection personnel, which must preferably take place remotely or, otherwise, guaranteeing the interpersonal safety distance of one meter.

Suspended leave

Ordinary medical and technical personnel, as well as personnel whose activities are necessary to manage the activities required by crisis units set up at regional level, are suspended.

Video link meetings

When conducting meetings, in all possible cases, remote connection methods must be adopted with particular reference to health and socio-sanitary structures, public utility services and coordinations activated in the context of the COVID-19 emergency. In any case, compliance with the interpersonal safety distance of one meter must be guaranteed.

Suspended driving examinations

Driving license eligibility examination procedures conducted in the local offices of Dept. of Motor Vehicles are suspended. With proper management measure, an extension is arranged in favor of candidates who were unable to take the exam due to this suspension.
